INTRODUCTION

This standard aims to give learners knowledge, understanding and basic skills in using MEWPS whilst carrying out work. It introduces learners to manoeuvring the machine in open and confined areas, daily pre-use checks, refuelling, hazards and risks involved with operating and working with MEWPs and to comply with health and safety legislation. The target audience is aimed at those working on the telecoms network including suppliers and contractors.

Performance Objectives

- Use suitable personal protective equipment throughout all MEWP operations
- Prepare the MEWP for work, undertaking all pre use checks and adjustments in accordance with standard procedures
- Carry out all work activities in accordance with relevant health and safety legislation
- Communicate with team members and other associated occupations about the MEWP operation and the work to be carried out
- Identify and explain the operation of the MEWP instruments and controls
- Position MEWP and any attachments used in an authorised position
- Check that any ancillary attachments are in working order
- Demonstrate safe travelling and manoeuvring activities
- **9** Be able to operate the MEWP and undertake specified working tasks
- Identify weights and centres of gravity of loads accurately
- Deal with any hazards and obstacles encountered during the operation in accordance with standard practice
- **9** Be able to select, transfer and position loads using a MEWP
- Comply with the relevant, current legislation, official guidance and organisational procedures to maintain safe work practices
- Shutdown and secure the machine, using correct procedures
- Undertake post operational checks for a MEWP

Assessment Criteria

- Outline the legislation relating to MEWP operation
- Demonstrate starting and stopping the MEWP, the emergency descent, safe operating area
- Manoeuver the machine accurately, forward and reverse, including braking
- O Use hydraulic controls correctly and at varying heights
- Judge the position of the platform at varying heights
- Mount, dismount and selection of harness
- Carry out ground and site appraisals prior to operation
- Comply with information and/or instructions derived from risk assessments and method statements
- Describe how to identify weight, quantity, length and area associated with the method/procedures to operate a MEWP used for accessing operations
- Minimise environmental damage to the work and surrounding area when preparing areas using a MEWP
- Prepare MEWP for operation; checking, setting up, adjusting, communicating, manoeuvring, positioning, accessing and setting down
- Identify types of MEWPs and their characteristics
- Carry out pre-operational checks for obstructions, stability, and ground conditions
- Use fall prevention equipment
- Avoid damage to structures and utilities service apparatus
- Shut down and secure the MEWP
- Describe how to maintain the plant and machinery, hand tools, ancillary equipment used to access working areas
- Clarify the importance of identifying the safe working load (SWL) of a MEWP and the implications of exceeding it
- Demonstrate how to convert the MEWP to transport position in accordance with the operator's manual
